



La Vie Factory's Commitment to the Alliance for Water Stewardship Standard

La Vie recognizes that the long-term and sustainable success of its business based on the sustainability of the water resources that it has been exploiting. That sustainability just only built upon the effective water stewardship in the aquifers and watersheds where its raw material sourced from, where its factories are located, and where its suppliers and consumers live. It believes that the effective water stewardship will require that provisions is made firstly for water to meet the human right to safe water, then ensure that ecosystems are able to function, and finally ensure that water is efficiently used for agriculture and industry. We believe that government has to take the lead in establishing over-arching water policies within which La Vie and other water users can operate. La Vie is willing to assist in this process, commits to develop its business in a way that facilitates effective water stewardship in the geographies that it sources from and operates within, and commits to focus upon measures that are cost effective and relevant within a watershed.

La Vie has long history of leadership on water stewardship through continuous improvements in the efficient use of water at its factory operations. The below commitments are for our continuous improvements and for the Alliances for Water Stewardship.

I commit to supporting La Vie factory's pursuit of responsible water stewardship.

I will support the site's efforts to achieve the outcomes of water stewardship as defined in AWS standard.

I commit to efficient use of water in whole factory operations by saving initiatives.

I commit to treat effectively the water we discharge by building up efficient treatment systems.

I will respect the rights of workers on site to have access to safe water, adequate sanitation and hygiene
